- The Kiosk will be complete and open by 1<sup>st</sup> June, in time for the Jubilee Celebration. The Lord Lieutenant will hopefully attend a grand opening of the hall.
- The AV has almost been completed.
- The Heras will be taken down once the hall is used.
- There has been no news regarding the child who tipped paint over the building. Councillor Green made comment it was nice that the public were supportive in their comments regarding this matter, on FB.
- Martin Nolan is watering the new laurel hedging twice a week.



• The Clerk advised she is still waiting on the insurers to update her on the current position of the nursery building repairs and maintenance.
